Main Duties

- Designs, schedules, and teaches Sanctuary's Classroom in the Field educational programs on forests, vernal pools, creeks, wetlands, and overall natural history for school age children, educators, resource management professionals and special audiences.
- Expands outdoor education programming to other county parks as possible and available.
- Recruits, trains, supervises, and evaluates Volunteer Naturalists who help lead Sanctuary education programs.
- Leads development and delivery of four to six weeks of summer camp programs ranging from preschool to high school aged children.
- Leads all administrative and outreach tasks pertaining to delivering the Classrooms in the Field & summer camp programming including monthly and quarterly reports.
- Develops curriculum for new educational programs as needed.
- Convenes the JBWS Educational Advisory Committee twice annually (or as needed) for advice, guidance, and feedback on Sanctuary educational efforts.
- Assist with Sanctuary public programs and special events.
- Other duties as needed.

Required Knowledge, Skills, and Abilities

- Considerable knowledge of principles of biology and ecology and other life sciences for conducting naturalist activities.
- Skill in developing and teaching outdoor educational programs for various age groups.
- Ability to plan, organize, develop, and lead naturalist programs.
- Strong communication and writing skills.
- Excellent time management skills and ability to multitask and prioritise work.
- Ability to motivate and train volunteers.
- Experience teaching in an outdoor setting.
- Experience in the management of website content and other social media outlets is a plus.
- Experience with delivering summer camp programs strongly preferred.



- Knowledge of Maryland flora and fauna preferred.
- Willing to work under strenuous weather conditions (heat).
- Canoe and kayak experience is a plus.
- A demonstrated passion and commitment for the natural world is a must!

Qualifications

- B.S./B.A. in Environmental education, Environmental Science, Recreation, or four years of experience in a related field.
- High proficiency in Microsoft office suite, Google suite products, and other computer skills.
- Two years of experience working with children of all ages.
- Must pass both drug and background screenings.
- Must have a valid state driver's license.

NOTE: The selection process includes a background verification to include a criminal history check. Possession of a valid Class C driver's license issued by the state is required. This is a safety sensitive position and employees in this position are subject to random Controlled Dangerous Substance (CDS) testing.
