

# Northern Virginia Soil and Water Conservation District

## Environmental Outreach Internship – Fall 2022



This fall internship position will support the Northern Virginia Soil and Water Conservation District's outreach and engagement programs. Through these efforts, we reach thousands of people and have a deep impact on the Fairfax County community.

The intern will support a variety of events and programs through office preparation and coordination in advance, staffing during the event, and follow-up afterwards. Programs include:

- Outreach Events or Festivals (evening or weekend)
- Volunteer Stream Monitoring
- Storm Drain Marking and Education
- Annual Native Seedling Sale
- Conservation Assistance Program
- K-12 In-person or Virtual Student Programming
- Envirothon Competition Trainings
- Potentially a Potomac Watershed Roundtable and/or Rain Barrel Workshop

In addition, the intern will support the development of outreach and informational material for delivery through social media (Facebook and Instagram), webinars, and printed material. Other duties that support NVSWCD's mission may be assigned as necessary and build upon the strengths and interests of the individual. Interns will report to NVSWCD's Communications and Education Specialist and closely coordinate efforts with other NVSWCD staff.

NVSWCD's interns work in a professional setting and acquire practical experience in data collection and management, as well as the development of programmatic guidance, execution of education and engagement programs, and informational or promotional materials for various audiences.

### **Skills and Abilities**

- Strong writing and speaking skills.
- Excellent attention to detail and organizational abilities.
- Professionalism and patience with partners, public, and students.
- Able to work independently; trustworthy and assumes responsibility easily.
- Performs well on a team, excellent relationship with colleagues and supervisors.
- Learns quickly, not afraid to troubleshoot independently and ask questions.
- Self-starter, able to meet deadlines.
- Desired: Experience with outreach efforts, social media, and web editing software.

The intern must display professionalism, patience, attention to detail, a willingness to learn, and a good sense of humor. Evening and weekend work may be required.

### **Education and Experience**

- Enrollment in or graduate of an accredited college or university with a degree in natural resources, environmental planning, environmental science, sustainability, or related area;
- A conservation ethos and/or an understanding and appreciation of environmental and conservation matters.

**Physical Requirements**

Ability to spend extended periods of time standing, walking, and ability to traverse rough and uneven terrain. Must be able to work in varying weather conditions. Must be physically able to lift 15 pounds.

**Conditions for Employment**

Must pass a criminal background check, a check of the Child Protective Services Registry, and a driver's license check to the satisfaction of the employer. Use of a personal vehicle required; mileage will be reimbursed at current IRS rate.

**Term & Compensation**

August 29, 2022 – December 9, 2022; 15 weeks, 20 hours/week, \$15/hr

The intern will be paid bi-weekly with staff payroll. Taxes will be withheld. This is a limited-term position that does not include benefits.
